**ORDER:**

The Special Rules of Animal Husbandry Services were issued vide G.O.1<sup>st</sup> cited, during the year 1993 to 1995, certain Veterinary Assistant Surgeons were directly recruited in the Department, and according to the rules then in force, they had to join the service within a period of 45 days from the date of Dispatch of the appointment orders. Certain of those Veterinary Assistant Surgeons were already prosecuting their M.V.Sc., and in order to complete their M.V.Sc., they requested the Government to extend the last date of joining in their favour and Government have issued orders extending the last date of joining prescribed under the rules, in their favour, by 3 months.

The Government vide reference 3<sup>rd</sup> cited, have issued the following instructions for fixing of seniority, in consultation with the General Administration (Ser.E) Department and law Department.

- i. The seniority of the individuals joined within the stipulated period of time may be fixed as per the point (d) of para 14 of instructions/ clarifications issued on determining the inter-se- seniority in respect of Direct Recruits vide Circular Memo No. 16/Ser/A/93-39, General Administration (Ser.A) Department, dated 21-04-1999, which is as follows:
- ii. "The inter-se- Seniority of direct recruits shall be as per the ranking assigned to them by the recruiting agency irrespective of their dates of joining provided they all joined within the time allowed for them to join as per rule 22 of the A.P. State and subordinate service rules.
