with orders laid down in G.O. Ms. No.45, AH & F (AH) Department,  
dated 31-03-2016, I am aggrieving with the following conditions.

- 1. Conditions of Appointment:** Purely temporarily appointment. Can be terminated with 30 days notice during temporary period without assigning any reason.
- 2. Tenure:** Contractual appointments shall be made for a tenure not exceeding one year or till the regular candidate is posted which ever is earlier.
- 3. Remuneration:** It is proposed a consolidated pay of Rs. 35,000/- per month which is equivalent to the basic pay of the Veterinary Asst. Surgeon in RPS, 2015.
- 4. Headquarters and transfer:** A person appointed on contract shall report at the place of his/her posting at his/her own cost, which will be treated as his/her headquarters. It shall be mandatory for the person to reside at his/her official headquarters. His/her working hours shall be the same as regular employees. Ordinarily, contractual appointees will not be transferred to other posts or stations. However, the Department reserves the right to transfer contractual appointees to other post of equal status or another station due to exigencies of work, or the performance of the individual.

**5. Disciplinary control:** Subject to the overall right of the Department to terminate the contract on giving one month's notice, or pay in lieu thereof.
