**II. All Zonal Cadre Posts in Zone VI - 12/06/2018 - 11.00 AM to 1.00 PM**

The Counseling scheduled on the above dates shall be held initially for the Veterinary Assistant Surgeons followed by Paravets [ viz Veterinary Livestock Officer, Junior Veterinary Officer & Livestock Assistant ] and then the Ministerial staff Superintendents & Senior Assistants ] sequentially.

The order of preference shall be followed as per the priorities mentioned in the G.O i.e Spouse grounds / Employees retiring before 31/05/2019/Persons having Disabilities / Employees having mentally retarded children / Widows / Medical grounds / Employees working in Hardship areas. The employees claiming for the preference are requested to submit the relevant certificates in original at the time of Counseling without fail.
